What to Expect

At the Casa de Esperanza y Sueños campus, you have the opportunity to connect with a group of people who are here to be your support team. We believe that recovery is a deeply personal experience and will do whatever it takes to support your journey during your time with us.

Our 15-bed facilities are staffed with a multidisciplinary team to assist you. This includes clinicians, psychiatrists, nurses, and residential care staff.

Our services emphasize choice-making skills and harm-reduction techniques. Staff work with you within your cultural dynamic in building independence and self-responsibility to nurture your recovery and successfully transition you home or to less restrictive community settings.

Supported Recovery

Your recovery plan starts with you. Upon arrival, a diverse clinical team will provide an individualized assessment and work with you every step of the way to support your goals in life.

- **Our staff** are passionate, resourceful, and motivated. They are your partners in recovery.
- Our culture is based on respect and non-judgment, and we celebrate individual uniqueness. We care about the interpersonal relationships we develop so we can maintain a supportive program setting.

Who is Served

Transitional age youth (TAY) and adults, aged 18 and older, who have been diagnosed with serious mental illness.

Services & Supports

- Psycho education groups
- Independent living (e.g. money management, community reintegration)
- Outings and other recreational activities or special events
- Medication assistance
- Symptom management and medical appointment assistance

How to Access Services

Our programs receive referrals from all community and county providers in Ventura. The majority of referrals go through Ventura County's continuum of care meeting, at which local providers discuss the best plan of action for each individual.

We do require that members are enrolled with the Ventura County Behavioral Health team prior to admission, therefore, all members accepted to our program must be open to the county prior to, or upon, admission. We are a voluntary program (not locked), meaning that potential members agree with our program policies and treatment structure before making the decision to come to the program. The members must have had no recent history of significant violence and should be able to administer medication independently (with staff monitoring). We also require that our members are ambulatory—our programs are Americans with Disabilities Act (ADA)-approved and medical assisted devices are permitted.
